
1. GENERAL PRODUCT INFORMATION

- 1.1. Product name: Quarter-turn gearbox ELEPHANT HAM RQNx-xZ-x.
- 1.2. Manufacturer (supplier): "ELEPHANT". Carrer d'Aragó,264,3-1,08007 Barcelona, Spain.
- 1.3. Purpose: The ELEPHANT HAM gearbox allows manual setting of the required positioning of the shut-off valve by a quarter turn, acting as an alternative to pneumatic, electric or hydraulic quarter-turn actuators. It is suitable for ball valves, butterfly valves, 90° butterfly valves and for controlling air dampers.





6. INSTALLATION AND OPERATING INSTRUCTIONS

- 6.1. The installation, operation and maintenance of gearboxes are allowed to personnel who have studied the product design, safety rules, requirements of this TA and have skills of working with gearboxes.
- 6.2 When working with the reducer, piping and fittings must not be under pressure. During installation and maintenance, the electric, pneumatic or hydraulic power supply to the actuators used with the gearbox must be cut off and precautions must be taken to prevent their unintentional activation.
- 6.3 Before mounting the gearbox to the pipeline valve, set the gearbox and the valve shutoff body in the "open" or "closed" position. Then mount the actuator on the square of the drive shaft and the connecting flange of the valve and fasten with bolts.
- 6.4 During installation it is forbidden to use wrenches with extended handles and other devices other than those provided for the product, as well as to strike the product.
- 6.5 Adjustment of the limit stop is carried out immediately after mounting the gearbox to the valve. The adjustment is always checked by manually setting the gearbox in the "closed" and "open" positions.
- 6.6 The suspension screw on the gearboxes is only used for lifting and necessary operations with the gearbox itself. It is strictly forbidden to lift or carry the valve + gearbox assembly by any gearbox components.
- 6.7 During manual operation, turn the gearbox mechanism with the hand wheel in the direction in which the valve opens or closes.
- 6.8 If the gearbox is in the end position CLOSED, but the valve has not shut off the flow, this indicates improper adjustment of the gearbox, or a malfunction of the valve, or some other fault.
- 6.9 It is forbidden to apply excessive force on the gearbox shaft in an attempt to turn the gearbox additionally and thereby move the shut-off valve to the desired position.
- 6.10. In order to avoid accidents, the general requirements for installation and operation must be observed during installation and operation in accordance with the company's procedures.



7. TRANSPORTATION AND STORAGE CONDITIONS

- 7.1. Storage should be carried out in the factory packaging in accordance with the procedure established at the enterprise.
- 7.2. The transportation of products must be carried out in accordance with the procedure established at the enterprise.

8. UTILIZATION

8.1. The product is disposed of in accordance with the procedure established at the enterprise (remelting, burial, resale).



9. WARRANTY OBLIGATIONS

- 9.1. Warranty period 12 months from the date of commissioning, but not more than 18 months from the date of sale.
- 9.2. The warranty applies to equipment installed and used in accordance with the installation instructions and product specifications described in this data sheet.
- 9.3. The manufacturer guarantees compliance of the product with safety requirements, provided that the consumer complies with the rules of transport, storage, installation and operation.
- 9.4. The warranty covers all defects caused by the fault of the manufacturer.
- 9.5. The warranty does not apply:
 - parts and materials of the product subject to wear and tear;
 - for cases of damage caused by:
 - modifications to the original design of the product;
 - violation of general installation recommendations;
 - faults caused by improper maintenance and storage; improper operation and use of the equipment.

10. WARRANTY TERMS

- 10.1. Claims to the quality of the goods may be made during the warranty period.
- 10.2. Defective products are repaired or exchanged for new ones free of charge during the warranty period. ELEPHANT decides whether to replace or repair the product. The replaced product or its parts resulting from the repair shall become the property of 'ELEPHANT'.
- 10.3. Costs related to dismantling, installation and transport of the defective product during the warranty period shall not be reimbursed to the Buyer.
- 10.4. If the claim is unfounded, the Buyer shall pay the costs of diagnostics and expertise of the product.
- 10.5. Products are accepted for warranty repair (as well as for return) fully assembled.
